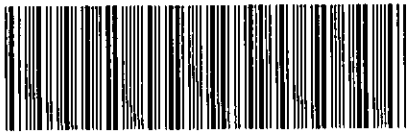

¹⁹ **Require** the respondent to surrender any firearm or other dangerous weapon, or any concealed pistol license, and prohibit the respondent from obtaining or possessing a firearm or other dangerous weapon, or a concealed pistol license.

Notice: If you **are** the respondent's intimate partner, after actual notice and an opportunity to be heard at the hearing, the court may be required to order the respondent to surrender firearms, other dangerous weapons, or concealed pistol license.

I want emergency temporary protection effective immediately, that lasts (up to 14 days) until the court hearing:

He called me 13 times this morning between 6:50 and 7:02. I then blocked his phone number. (9-15-16)

I have asked him multiple times to not come to my house. He has still come here after I put a NO TRESPASSING sign and a lock on my gate. on September 8th

- He refuses to return my shed key or change his mailing address since he moved out on 7-20-16

He pushed me down three times in one night - 7/20/16



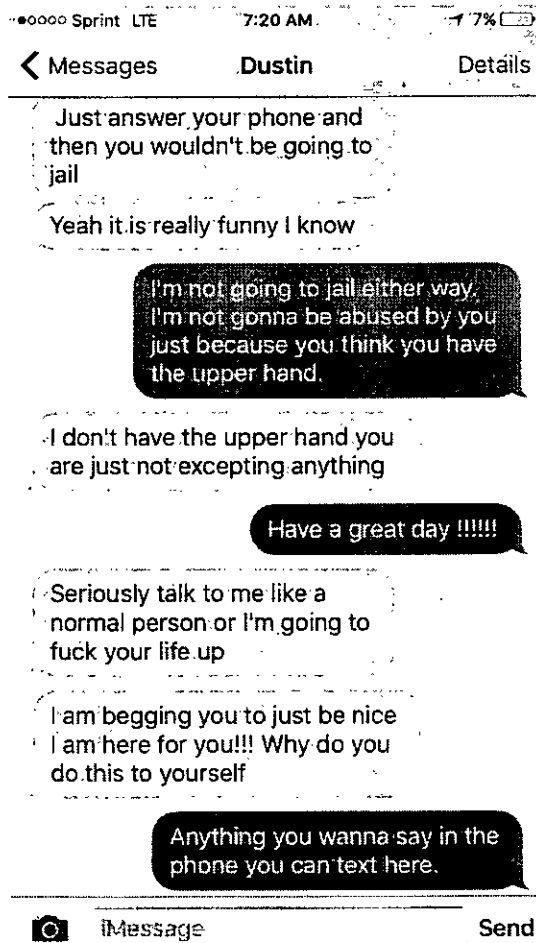

Statement Continued: On 7/20/16 Dustin moved out of the house that I own after a fight. He had lived at my home from April 2016 to July 20th 2016. He told me that he did not have a place for all of his belongings. I had agreed to let him use my shed for storage until he could find a place to keep his things (tools, vacuum, random household items). Since then I have asked him what his timeline is or what his plan is but he refuses to give me an answer. The agreement was that he would leave the key under a rock but recently he has taken the key and locked me out of my own shed. He will come to my home while I am at work even though I have asked him to please ask before he comes. He is not paying me any type of storage fee and I have asked him multiple times to stay away until he is ready to take everything all out at once. He uses it as an excuse to come to my property and stalk me. I have received multiple text messages from him about me hanging out with people when no one has told him that information which makes me wonder if he has a secret camera hidden on my property to spy on me. Although Dustin has not lived here since 7/20, he still refuses to change his mailing address after I have asked him multiple times. He is living with his Father in Bonney Lake but uses "getting his mail" as an excuse to drive by my house. My mailbox is locked and he refuses to give me my mailbox key back after asking him multiple times. I feel violated and scared to come to my own home because I never know if he will be there.



Additional Stalking statement: I went on a trail ride with a mutual friend of ours on Monday September 12th. Geoff parked his truck at my house and we were gone for a few hours. The next day he texted Geoff: "In the next couple days you need to give me a call. I need to have a little chat with you. Just not tonight." And then on Thursday the 15th, Dustin texted Geoff again and asked Geoff when he was "planning on filling him in". Geoff is just a friend and there is nothing more to it than that but Dustin is calling me a "whore" because he somehow knows that we hung out. There is no way he would have known that Geoff was at my house unless he drove by or he has a camera at my house in my shed.

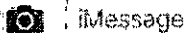

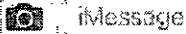
